Covid Visitation Conditions March 2021

- 1. For ALL visitors -
 - a. Must enter the building prior to 6:00PM and after 7:00AM, as doors will be secured thereafter.
 - b. For the comfort and convenience of all of our residents and patients, our preferred visiting hours are 8:00AM to 8:00PM
 - c. Visitor must be donning a mask covering mouth and nose.
 - d. Visitor must respect 6' of Social Distancing throughout the building.
 - e. No more than 2 visitors at a time per resident/patient.
 - f. The resident/patient must be donning a mask covering mouth and nose.
 - g. Visitations will **NOT** be allowed for those residents/patients who are confirmed or suspected positive with Covid19.
- 2. NOT Vaccinated visitor and/or NOT vaccinated Resident or Patient -
 - a. In-room visits will not be allowed. However, in-person supervised and prescheduled visits and/or virtual visits remain in place.
 - b. Call Sister Theresa at ext 2105 in advance to schedule your appointment.
 - c. Visits are limited to 45 minutes, and may be limited to one visit per week.
 - d. Late arrivals will not justify an extension of the previously reserved time slot.
 - e. Reservations may be given on a first come, first served basis.
 - f. Visits may be supervised by a qualified Caregiver.
 - g. Visitors and the resident/patient will be escorted to a reserved area of the building.
 - h. Visitors MUST maintain 6 feet of social distancing at all times.
 - i. No eating or drinking while visiting with the resident/patient.
- 3. FULLY vaccinated visitor AND fully vaccinated Resident or Patient -
 - a. Private in-room visitations will be permitted.
 - b. No appointment is necessary.
 - c. Fully vaccinated refers to 14 days post the second inoculation of the Pfizer and Moderna vaccinations; or 14 days post the first inoculation of the Johnson and Johnson vaccination.
 - d. Both visitor AND resident/patient must be fully vaccinated.
 - e. The **roommate** of the visited resident/patient must be fully vaccinated.
 - i. In the event of the roommate not being fully vaccinated, the visit may at the option of the facility be relocated to a secure area.
 - f. Visitor must pursue a direct path to the resident/patient room and NOT -
 - i. Stop or pause along the way.
 - ii. Visit or talk with other patients or residents.
 - iii. Visit restrooms, kitchenettes, vending machines or other common areas.
 - g. While in-room visitations are private, it is strongly encouraged that visitors and residents/patients remain socially distanced and refrain from hugs, kisses, etc...
